Act 1 provides that Abington School District, at its option, may place a referendum on the November 2019 ballot for the purpose of seeking voter approval to levy, access, and collect an Earned Income Tax with a new Net Profit Tax or a new Personal Income Tax for the purpose of annually funding additional property tax relief. If the Board of School Directors selects this option, then the law mandates the inception of a Tax Study Commission, certain actions, and timelines.
