AFFIDAVIT of PROBABLE CAUSE

On Monday, February 12, 2024, the Montgomery County Detective Bureau received information concerning a sexual assault. Abington Police Detective Sergeant Troy Hummel related that on this same date, his agency was contacted by officials at Abington High School. It was reported to Sgt. Hummell that a 17 year old female student, hereunto referred to as NB, told her counselor that she has been having a sexual relationship with an Abington School Resource Officer by the name of Jordan Jones.

A minimal facts interview was conducted by Sgt. Hummell with NB, a 12th grade student at Abington High School. NB told Sgt. Hummell that she first met SRO Jordan Jones while attending Abington High School during the 2022-2023 school year. In the fall of 2023, Jones asked NB if she would be interested in walking his pet dog. NB agreed and the two began seeing each other outside of the school setting.

NB said that she went to Jones' home in Horsham Pennsylvania and was able to provide a description of his home. In November of 2023, NB and Jones became involved in a sexual relationship, engaging in oral and vaginal intercourse. This relationship consisted of the two having sexual intercourse an estimated 15 different times and continued through the school year.

I learned from Sgt. Hummell that Jones is an active full time Police Officer with the Abington Police Department. Jones' current assignment is one as a School Resource Officer, assigned to Abington High School. Due to this information, the Montgomery County Detective Bureau assumed the role as the lead law enforcement agency.

On Monday, February 12, 2024, a consensual phone call was conducted between NB and Jones, which was monitored by your affiant. During this conversation, Jones made admissions acknowledging that the two had a sexual relationship. Jones also made comments acknowledging that he was aware that the relationship between the two is illegal. Jones made comments such as "I trust you, I know you wouldn't try to get me arrested or anything", "that's a big risk, of course. And I took that risk because I care about you" and "If we were to date, my life would be over".

Based on the aforementioned information, Jordan Jones is being charged with the previously listed violations of the Pennsylvania Crimes Code.

I, DET. WALTER KERR, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.
