

A change to school organization, including changes to the grade structure.

School Closure


Closure of a school building to educational use. Schools should not be closed during the school term except under certain circumstances with approval from the Pennsylvania Department of Education.

School Reconfiguration Options

Status Quo

EP stays open during the 25-26 and 26-27 school years.

Rising 5th graders remain in elementary schools for the 27-28 school year.

Rising 6th graders attend Cedarbrook for the 27-28 school year.

Leasing

Both 5th and 6th grades move into leased space for the 25-26 and 26-27 school years.

Rising 5th graders remain in elementary schools for the 27-28 school year.

Rising 6th graders attend Cedarbrook for the 27-28 school year.

Immediate Move-EP Open

Rising 5th graders remain in elementary schools for the 25-26 school year.

Rising 6th graders move to the modulars for the 25-26 school year and remain for 26-27 school year.

Rising 6th graders move to Cedarbrook for the 27-28 school year.*

*Determination would need to be made regarding EPIC's location.

Immediate Move-EP Closed

Rising 5th graders remain in elementary schools for the 25-26 school year.

Rising 6th graders move to the modulars for the 25-26 school year and remain for 26-27 school year, <u>and are</u> <u>incorporated into CBK.</u>

Rising 6th graders move to Cedarbrook for the 27-28 school year.*

*Determination would need to be made regarding EPIC's location.



With an immediate move, EPIC:

- May remain at the Modulars with 6th grade
 - Two separate start and end times for the day
 - Separate bus routes
 - Careful scheduling of shared spaces
- May move to leased location if 6th grade moves to the Modulars, as there is a significantly smaller number of students attending EPIC and the cost would be lower
- Administration would suggest a long term lease to maintain the program, which has proven effective

Key Assumptions

Status Quo

- The systems are maintainable
- Our Flexible Instruction Day application is approved by the state in case of emergencies


Leasing

- We are able to locate a suitable space of the correct size
- The space doesn't require a tremendous amount of work
- The cost of the lease is less than the cost of systems maintenance at EP

Immediate Moves

- There is sufficient space at each elementary school to accommodate rising 5th grade students
- There is sufficient space at the Modulars to accommodate the rising 6th grade students

Curriculum, Instruction & Programming


5th Grade

- Master Schedules would need to be adjusted
- Would remain co-taught
- Will utilize existing instructional materials
- Students who receive special education supports and services can be absorbed into elementary school caseloads in 3 out of 4 elementary schools

6th Grade

- Schedule would mimic schedule at Cedarbrook Middle School
- Special education programming would need to be maintained, even with move to Cedarbrook in the 27-28 school year
- Some instructional materials would be replaced; currently utilized materials would not be moved







Cost Details

Status Quo

- Current repairs hold (no additional cost)
- Immediate needs: Heating Pipe Fix (\$1.5 million)
- Potential additional infrastructure costs (essential systems estimated \$12.1M)

Leasing

- Cost of the lease itself
- Costs associated with leasehold improvements
- Additional utilities and insurance

Immediate Move

- Overall cost neutral
- Some cost savings from utilities savings
- Cost savings from not having to expend funds on systems maintenance

\$~1.5M

Cost for maintenance if we maintain status quo. There is for HVAC piping, but there will be additional costs

\$~1.2M/Year

Cost of a Lease for a space to house 5th and 6th grade, exclusive of cost of an additional move

Embedded Costs

Moving Costs

- Moving Company vs.
 Overtime
- Payment to CEA staff for moving classrooms

Transportation

- We will eliminate the current Elkins Park schedule if an immediate move occurs, 6th grade would mimic Cedarbrook's start and end times
- We'd move from 4 timelines to 3 for buses
- Parking needs to be considered

Professional Development

- PD would be provided for teachers switching content areas and for transition
- Summer Institutes

Food Services

- Food quality may differ at the Modulars with the increase in numbers if an immediate move occurs
- This would be temporary and until 6th grade moves to Cedarbrook

Other Staffing

 We are examining counseling, nursing, related services, specials/encore, challenge, interventionists, SSOs, custodial, IT and other staffing ratios as well

Administrative Adjustments

 We will likely need assigned or floating assistant principals at each elementary school



A full logistics, implementation, and communications plan will need to be developed as soon as possible.
